Permitted Low Production Well Registration Application

Tier 3

The District amended its well exemption rules on September 9th, 2025, to allow only the statutory well exemptions listed in §36.117 of the Texas Water Code (Statutory Exempt Wells). The District will respect and uphold all well exemptions that were granted under the District's Rules prior to September 9th, 2025, unless the usage changes and the exemptions conditions are no longer met. To qualify as a Regulatory Exempt Well under District Rule 3.2.A. the water well owner must of applied for and received an exempt well registration prior to September 9th, 2025 or be a water well that is exempted under District Rule 10.5.

New water wells drilled on less than ten (10) acres or wells that are located in a subdivision of land for which plat approval was required by Chapter 232 of the Local Government Code are not considered exempt under Rule 3.2.A.

All permitted water wells are required to register and obtain an operating permit. This application is to register a Permitted Low Production Well. Permitted Low Production Wells are water wells that are not exempt under District Rule 3.2.A. and are equipped to produce at the instantaneous rate of five (5) gallons per minute or less <u>and</u> also do not produce more than one acre-foot annually. Permitted Low Production Wells also require an Operating Permit application.

Water well owners who seek to produce more than five (5) gpm <u>or</u> more than one (1) acre-foot annually are not considered Permitted Low Production Wells and should use the Application(s) for a Permitted Non-exempt Well.

Please note All Permitted Low Production Wells must be equipped to produce at the instantaneous rate of 5 gallons per minute or less <u>AND</u> produce less than a total annual production of 1 acre-foot (325,851 gallons).

Permitted Low Production Wells are allowed to be no closer than 50 feet from the property line and no closer than 100 feet from an existing well.
