An application for an operating permit shall be submitted on this form and shall be signed and sworn to by the well owner as required by Texas Water Code Section 36.113(b). The operating permit application must be granted by the District prior to the proposed production of water in accordance with the provisions of District Rules.

Rule 3.3.A is the section in the District Rules that relates to the application process for an operating permit. While this application attempts to request all the items listed in Rule 3.3.A., some of the requested items will have to be submitted as attachments to this application. Please refer to District Rule 3.3.A. for a complete list of all required items.

The applicant must provide evidence that they have the legal authority to produce the groundwater associated with the land surface and the permit application. The applicant must also provide any documents that transfers that right to own, control, or produce the groundwater rights to another person/entity that are associated with the land surface and the permit application. A permit may be amended or revoked if the groundwater rights or right to produce are legally transferred to another person/entity. The applicant shall attest to the information required in this rule by a District-provided affidavit form and submit the affidavit with the permit application;
